Dear Honourable Mr. Tsang,

Re : Constitution Reform Committee

We are a group of the Election Committee ("EC") members. We have called ourselves the "EC Forum" since the year 2000. Our Forum is an informal, non-political and non-pressure group. The object of the EC Forum is to promote a closer network of communication and strong commitment in building a better Hong Kong. We care about Hong Kong. We meet regularly to exchange views on all issues facing Hong Kong from our different points of view. Most of our members are elected representatives by the various professional and sub-sectors in Hong Kong.

On the subject of Constitution Reform, it is our belief that the Basic Law and One Country Two System must be maintained. We, the Election Committee Members, are entrusted under the Basic Law to elect our Chief Executive. We represent the interests of the diverse sectors of Hong Kong. Therefore, we are an electoral body with public support and participation through their votes to choose us as their election representatives.

After discussion among ourselves, we have developed the following suggestions and ideas for your kind consideration :

1. The Election Committee Members are an established pool of competent voters for the Chief Executive. Consultation with the Election Committee Members is necessary on the constitutional reform.
2. A wider coverage of more sectors can be considered for Election Committee. Composition of EC Members can be reviewed. According to Basic Law Annex 1 item 7, we consider an enlargement in number of the EC members after 2007 necessary in order to provide a wider representation of our community.
3. On the issue of nomination of the Chief Executive, we consider that the Election Committee, as currently constituted, already sufficient to reflect this wider representation. We therefore recommend maintaining the role of the Election Committee in its current form.
4. Constitution Reform must be done in a progressive manner and we must not rush into any conclusion. We must maintain Hong Kong's stability and prosperity.
