Dear Sir/Madam

Re: my view on the issue of principle and legislative process relating to constitutional development of Hongkong.

Before I submit my view on the above issue, I would like to lay down the basic foundation of my belief.

I, as a citizen of Hongkong and thus a citizen of the People's Republic of China government, do believe that my freedom and my rights to choose are God's given rights, and not hand-down by any other men. I also believe that any government, on this earth, are formed ONLY by the authorization and amended by all his people on the condition that this government serves the majority needs of the people. Thus the people are the boss of the country, represented by the present government in order to serve the needs of the people, and not vice verse.

Therefore when a government claimed its present policy is for the good of the majority of its people, but facing a huge opposition from its people. There is the time when a government should asked itself who the boss really is? History has shown us again and again that whatever government who opposite and ignore the needs of its people is bound to throw-down by its people.

In refer to your paper by the Constitutional Development Task Force in gathering public views on the issue of principle and legislative process relating to constitutional development as laid down in the Basic Law, on February 18, 2004.

A. Principles.

A1. How could Hongkong's political structure develop in accordance with the following principles in the relevant Basic Law provisions which relate to the relationship between the Central Authorities and the HKSAR? Since Hongkong is under "One Country, Two Systems" in according to Basic Law, therefore the people of Hongkong can have the choice of the system they prefer. A general voting by all voters of Hongkong should constitute the choosing of the majority people. It is the duty of the Chief Executive to carry out the will and serve the people of Hongkong, let the Chief Executive be reminded that his salary is paid the people of Hongkong.

A2. On the principles of "actual situation" and "gradual and orderly progress"? A general voting by all voters of Hongkong is the "actual situation" and an orderly progress". I am 54 years old, do "gradual" means that I will not see any progress during my lifetime? To me, gradual means "Today", and I can forget all those empty promises of a better future.

A3. Base on Mr. Ji's explanation in 1990, how could the development of Hongkong's policy structure meet "the interests of the different sector of society" and "facilitate the development of the capitalist economy"? For the past seven years, the Hongkong's policy structure served the need of the rich. ! It is the interest of the rich people in Hongkong who hold the wealth as well as the power. It is time for the majority of the people of Hongkong, that is "the interests of the OTHER sector of society" be respected and be served. Development of capitalist economy based on the freedom of choice by the people and for the people, NOT by the rich and for the rich alone.

B. Issues on Legislative Process.

B1, B2 and B3. Legislative Council reflects the views of the people. Let the people vote and tell the government what the people's decision are.
