Proposal on the Constitutional Development of HKSAR by The League of Health Professionals of HK(LHP)

Hong Kong's future constitutional development definitely affects every member of our society. It affects the government, our economy, our social and even our health development. As we all aware that our population is aging and having a long life-span ranked third in the world, we do have to look at the development of the health professionals as a whole in order to fulfill the need of the public of Hong Kong in the years to come.

1. Beside nursing, we would like to have another seat in LegCo which represent the other 25 health professions (approx. 20,000 people)

2. For being an Election Committee Members for Chief Executive election in the future, we prefer to be in proportion to the number of professionals in different disciplines so that they can have a chance to express their views.
