Submission on the Constitutional Development of HKSAR by The League of Health Professionals of HK

Hong Kong's imminent constitutional development would spare none in our society. It is overall effect on the government spills over to our economy, our social and health issues. The SAR population cannot be but aging with a merciful long life-span ranking third in the world, and we must look closely at the progress of our health professionals globally so as to be ready for the needs of the Hong Kong public in the years to come.

A main mission of The League of Health Professionals of HK, which was founded by professionals from 13 health disciplines including dentists, dietitians, dispensers, doctors, medical laboratory technologists, nurses, occupational therapists, optometrists, pharmacists, physiotherapists, prosthetist-orthotists, psychologists radiographers and traditional chinese medicines practitioners, is to support the growth of the health professions for serving the community. Therefore, we would like to ensure that their expertise can be put to full use in public service.

Taking into consideration on our duty owed to the public as professionals, we would like to take interest in the appropriate development of every health professional in the society. Even though we are in the Health Services Functional Constituency, with

approx. 20,000 professionals, nursing being the majority of the voters in the group. We still feel somewhat restrained in the promotion of our objectives for the general good of the public. We feel that nursing is a big group and they deserve to have their own seating in LegCo in order to look after their actual needs. In view of the above, what immediately leaps to mind is the question whether we have been enjoying a sufficient representation in the political structure.

We fully understand that changing the methods for selecting the Chief Executive in 2007 and the forming of the Legislative Council in 2008 requires a consensus among LegCo, Chief Executive and the Standing Committee of the National People's Congress. We support for the democratic election with the public being able to elect their own CE and LegCo members. If in the year of 2008, we will enlarge the functional constituency seats, we would like to propose the following which we believe will enhance our health and economy through better representation from our sector, even though it might be only one year.

- 1. Besides nursing, we would like to have another seat in LegCo which would reflect better representation of the other 25 health professions (approx. 20,000 people).
- 2. For being an Election Committee member in the future, we prefer to be proportional to the number of professionals in different disciplines so that they would enjoy a fair opportunity in expressing their views.

We hope that the Constitutional Development Task Force and the government will consider our recommendation and we look forward to contributing to our community in HK. If you need further information, please feel free to call the undersigned at
